■ 商务部发布执行世贸组织贸易救济争端裁决暂行规则(来源: mofcom.gov.cn, 2013 年7月30日)

MOFCOM Issues Tentative Rules for Implementing WTO Verdicts on Trade Remedy Disputes (Source: mofcom.gov.cn, Jul 30, 2013)

7月29日,商务部发布了《执行世界贸易组织贸易救济争端裁决暂行规则》(以下简称《规则》),自公布之日起施行。《规则》明确商务部可依法在世贸组织要求我国反倾销、发布帖或保障措施与世贸组织协定一致时,建议或决定修改、取消相应措施。

On 29 July, MOFCOM released the Tentative Rules for Implementing WTO Verdicts on Trade Remedy Disputes (hereafter referred to as Rules), which came into effect on the date of release. The Rules clarifies that MOFCOM may advise or decide to revise or cancel relevant measures when WTO requires China to ensure the consistence of anti-dumping, anti-subsidy or provisional measures with WTO agreements.

根据《规则》,商务部可在作出建议或决定前对有关案件进行再调查。商务部决定修改或者取消价格承诺、承诺、数量限制等措施,或者决定采取其他适当措施的,应当发布公告或者以其他方式通知案件利害关系方。

According to the Rules, MOFCOM may launch investigations before it makes recommendations or decisions on certain cases. MOFCOM should release an announcement or inform interested parties using other means when it decides to revise or cancel measures for price undertaking, commitments or quantitative restrictions.

最高法日前发布《最高人民法院关于公布失信被执行人名单信息的若干规定》。《规定》将于2013年10月1日起施行,具备履行能力而拒不履行义务的失信被执行人将被纳入信用"黑名单",并予以公布。《规定》明确规定了对失信被执行人进行信用惩戒。《规定》明确了失信信息记载内容、公布范围和方式,并依托社会信用体系推出定向通报制度。《规定》要求公布失信被执行人的身份证号码,以保护其他公民不因同名同姓而损害名誉。

The Supreme People's Court has issued the Provisions of the Supreme People's Court on Releasing the List of Judgment Defaulters in Enforcement Proceedings (the Provisions), which shall come into force on 1 October 2013, the Provisions state that the courts will create credit "blacklists" of persons who have the capacity to perform but fail to perform the judgments in enforcement proceedings and make them available to the public. The Provisions also specify the punishments that the judgment defaulters will receive. The information relating to persons who fail to perform court judgments, the scope and method of such information releases are also specified in the Provisions, and a regular reporting system will be developed through the social credit system. The Provisions require releasing the ID number of the defaulter so that other citizens with the same name will be protected from defamation.

近日, 江苏省人力资源和社会保障厅公布了《江苏省劳动人事争议调解仲裁办法》 (以下简称《办法》), 自 2013 年 8 月 1 日起执行。1995 年 1 月 13 日江苏省人民政府 发布的《江苏省企业劳动争议处理办法》和 2005 年 12 月 7 日发布的《江苏省人事争 议处理暂行办法》同时废止。

Recently, the Jiangsu Human Resources and Social Security Bureau released the Measures for Mediation and Arbitration of Labour Disputes (hereafter referred to as Measures), which will be implemented from 1 August 2013. The Measures for Jiangsu Enterprise Labour Dispute Settlement released on 13 January 1995 and Interim Measures for Jiangsu Labour Dispute Settlement released on 7 December 2005 will be nullified at the same time.



《办法》也适用于外国人、无国籍人及港澳台居民,并对江苏省劳动争议调解、仲裁程序做出了相应规定,其中明确劳动人事争议案件代理人不得从事风险代理。

The Measures also applies to foreigners, stateless persons and residents of Hong Kong, Macau and Taiwan, and stipulates the corresponding regulations for labour dispute mediation and arbitration procedures. It clarifies that attorneys may not charge contingency fees for labour dispute cases.
